### Objectives and Investment Policy

#### Objectives

The fund aims to provide long term capital growth by investing in equities of emerging market companies worldwide.

#### Investment Policy

The fund invests at least 80% of its assets in equities of emerging market companies worldwide.

The fund may also invest in companies headquartered or quoted on developed markets if those companies derive a significant proportion of their revenues or profits in emerging markets.

The fund may also invest in other equities, collective investment schemes, closed ended funds, bonds and warrants, and hold cash.

The fund may use derivatives with the aim of reducing risk or managing the fund more efficiently.

#### Benchmark

This unit class is managed with reference to the MSCI Emerging Markets Index GBP. The manager invests on a discretionary basis and is not limited to investing in accordance with the composition of this benchmark.

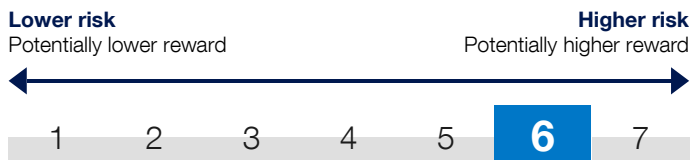
#### Dealing Frequency

You may redeem your investment upon demand. This fund deals daily.

#### Distribution Policy

This unit class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the unit class.

### Risk and Reward Profile



#### The risk and reward indicator

#### Risk factors

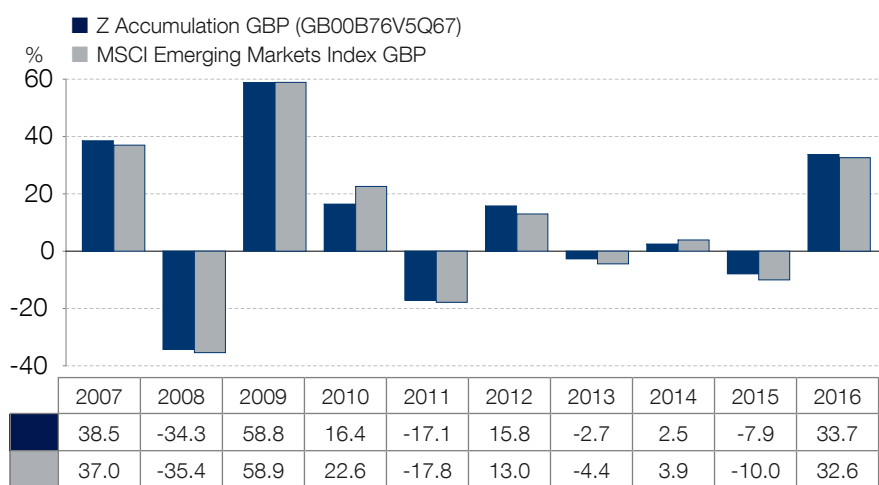
The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
